

## Dignity in Life Award

Dr. Thomas W. Hilgers and his wife Sue received the Dignity in Life Award in December 2012. Bestowed on them by the John Paul II Life Center at their second annual benefit dinner, the Dignity in Life Award honors Dr. and Sue Hilgers for their pioneering work in developing NaProTechnology.

## Building a Culture of Life in Women's Health Care

### Living the Dream to be a NaPro Physician

Kristina Pakiz, MD, experiences a rewarding career as an obstetrician-gynecologist. This reward comes to her, not by whether she is able to drive the latest Ford, GM, or Honda offering, but in the lives of the women and families that she touches.

Dr. Pakiz first knew that she wanted to become a doctor when she was in grade seven. That was when her class studied life science. Her journey toward her medical career began with the developing fascination that she had with learning about the anatomy and physiology of the human body. Along the way, Dr. Pakiz received the encouragement of some of her instructors, notably an anatomy teacher from Plattsmouth High School – Mr. Don Freeburg. He encouraged his students to consider medical careers after he himself was discouraged from doing so because he would have been an "older student" at the time.

"In college, I questioned it," said Pakiz, referring to her desire to become a physician. "I did not want to become a doctor just because it was what I had always thought." So, she began volunteering in medically related areas and shadowing physicians.

As part of a college Bible study, Pakiz was exposed to the book *Physicians Healed*, edited by Cleta Hartmann. Through this book, Dr. Pakiz learned about the Pope Paul VI Institute and, the summer after her graduation, she worked there as a research assistant. It was during this time, steeped in Catholic medicine, that Dr. Thomas W. Hilgers became her mentor. "I had never even considered being and OB," said Pakiz, "because I did not know how I could without prescribing the pill."

With a firm resolution, she encountered her next major challenge. "You must do well on a standardized exam to enter medical school," said Pakiz. Despite the hurdle of the MCAT and the anxiety of getting into medical school, Pakiz was accepted to the University of Nebraska Medical Center.


Medical school was also a challenge to Dr. Pakiz' convictions. "There was an attitude that pro-life students should go into non-controversial fields like

ophthalmology," she said. "On rotations I had to be careful about the openness of my view points. Interestingly, in one class, we had small group discussions on ethical issues. The doctor leading the group was so liberal that she embraced my views because I was so different."

"I think the most unique aspect about what we do is our approach to diagnosis and treatment, which looks for the root cause as opposed to treating symptoms. We also use the Creighton Model chart to get a deeper insight in our patients' health."

"Our initial evaluations are usually much longer than their previous experiences with other physicians," said Pakiz. "And, our patients say that we are much more thorough in taking their history, too."

But, her hard work pays off when she helps couples to achieve pregnancy and when she helps single women to become pain-free and resume normal lives with restored health. Those are her "rewards" as a NaPro physician.



## If not the Creighton Model,... I'm not sure I would have been able to carry my three boys.

I started charting with the Creighton Model before we got married. We learned other methods prior, but it was not until learning the Creighton Model that I felt confident in understanding my fertility.

When I was expecting my first boy, the Creighton

Model predicted decreased progesterone. At the recommendation of the Pope Paul VI Institute, I immediately had my progesterone levels checked and they came out normal. Two weeks later the progesterone dipped so low that I was put on Progesterone to prevent a miscarriage. I continued on Progesterone until 37 weeks for each pregnancy.


I remember someone saying that "you can see in the chart what you can't see in the blood work". No other methods could have predicted the progesterone fluctuations as well as the Creighton Model.

My husband and I are faithful supporters of Pope Paul VI Institute. We feel that the research and the science that Dr. Hilgers and his team perform is the future of reproductive medicine. Dr. Hilgers is the only doctor I

know who addresses women's health based on scientific evidence. Dr. Hilgers helps to treat the actual problems associated with infertility and women's health without simply masking them with medication.

## WAYS TO GIVE to the Pope Paul VI Institute

There are several ways you can make a gift in support of the Pope Paul VI Institute. Your tax-deductible gift will ensure that Pope Paul VI Institute continues its mission of Building a Culture of Life in Women's Health Care.

#### **GIFTS THROUGH YOUR WILL**

Your will is the your most important legal document in your estate planning efforts. Good planning preserves assets so that they will be used according to your wishes, provide security for your loved ones, and achieve your charitable objectives. Bequests take various forms:

- specific designates the Institute to receive a specific piece of property (example: "I bequeath to the Pope Paul VI Institute Omaha, Nebraska, all of my shares in 'XYZ Mutual Fund' to be used for its exempt purposes.")
- general designates the Institute to receive a specified dollar amount (example: "I bequeath to The Pope Paul VI Institute Omaha, Nebraska the sum of \$100,000 to be used for its exempt purposes.")
- residual designates all or a portion of the remainder after all debts, taxes, expenses and other bequests have been paid (example: "I bequeath to The Pope Paul VI Institute, Omaha, Nebraska, and fifty percent (50%) of the rest, residue and remainder of my estate to be used for its exempt purposes.")
- contingent takes effect only if the primary intention cannot be met, which ensures that property will pass to the Institute rather

than unintended beneficiaries, including the government (example: "If [NAME OF PRIMARY BENEFICIARY] does not survive me, then I bequeath to The Pope Paul VI Institute, Omaha, Nebraska, all the rest, residue and remainder of my estate to be used for its exempt purposes."

#### **GIFTS THAT PROVIDE INCOME**

Life-income gifts provide mutual benefits to both the giver and receiver. They allow you, the giver, to enjoy the benefits of an increased return on your investment income while also providing significant resources for the Pope Paul VI Institute or program of your choice. Life-income gifts include charitable gift annuity, deferred charitable gift annuity, or charitable remainder trust. Benefits of life-income gifts include the following:

- A stream of income for life, possibly to more than one beneficiary
- A charitable income-tax deduction in the year you make the gift
- A charitable estate-tax deduction for a portion of the gift
- A gift that will benefit Pope Paul VI Institute now and in the future

#### GIFTS OF STOCK OR OTHER PROPERTY

Gifts of appreciated securities are convenient and offer tax advantages including forgiveness of the tax on capital gain and an income tax charitable deduction for the fair market value of the securities.
